**COURSE DESCRIPTION**

This course introduces the major theory, safety practices, and techniques for shielded metal arc welding (SMAW) in the vertical position. Qualification tests, vertical position, are used in the evaluation of student progress toward making industrial standard welds. Topics include: Vertical SMAW safety and health practices, selection and applications of electrodes for vertical SMAW, vertical SMAW joints, vertical SMAW specification and 5G Open Root Pipe.

This course outlines: Vertical SMAW Safety and Health practices, Selection and Applications of Electrodes for Vertical SMAW, Vertical SMAW Joints, Vertical SMAW Specification and 5G Open Root Pipe.

## **WITHDRAWAL PROCEDURE**

Important – Student-initiated withdrawals are not allowed after the 65% point. Please note: Abandoning a course(s) instead of following official withdrawal procedures may result in a grade of "F" (Failing 0-59) being assigned.

Informing your instructor that you will not return to his/her course, does not satisfy the approved withdrawal procedure outlined above.

There is no refund for partial reduction of hours. **2. Second Offense**

Student is given a grade of "WF" (Withdrawn Failing) for the course in which offense occurs. The Registrar will input the incident into Banner for tracking purposes.

**3. Third Offense**

Student is given a grade of "WF" for the course in which the offense occurs. The instructor will notify the student's program advisor, academic dean, and the Registrar at the student's home campus indicating a "WF" has been issued as a result of third offense. The Vice President for Student Affairs, or designee, will notify the student of suspension from college for a specified period of time. The Registrar will input the incident into Banner for tracking purposes.
